4. OUR SERVICES FOR VICTIMS

Laboratory of innovative practices

Conjugal violence and post-separation

Juripop operates a legal laboratory with the aim of documenting barriers to access to justice and developing best legal practices. To this end, Juripop represents a limited number of victims and survivors in family and youth courts, free of charge.

We offer a program at the crossroads of psychosocial and legal intervention that combines, among other things, an ongoing analysis of the risk of aggravating post-separation violence.

Sexual violence

Juripop also operates a legal laboratory in civil and administrative matters to document obstacles and develop the best legal practices to better meet the needs of victims and survivors of sexual violence.

To this end, Juripop represents a limited number of victims free of charge.

• Free support and advice in cases of psychological or sexual violence in the workplace.

Juripop offers free and confidential legal services to anyone who has experienced sexual or psychological violence or sexual harassment in the workplace. We help people understand their rights and take the legal steps that meet their needs.

Resource center against harassment and violence in the cultural sector (l'Aparté)

The mission of this center is to offer initial assistance to anyone in the cultural sector who has experienced or witnessed harassment (psychological or sexual) or violence in the workplace (sexual assault).

We are able to welcome, support, direct and accompany people through the various steps and recourses to be undertaken.

Our services are free, confidential and independent of professional associations or groups.

5. OUR COMMITMENTS TO YOU

Juripop is committed to offering a respectful and caring service that respects the pace of everyone.

Juripop believes in the agency of the people who require its services and is committed to providing all the information necessary so that the person can make the choices that are right for them at all stages of the services they may require.

Juripop also undertakes to consider the security issues surrounding the person and to ensure that there is a minimum safety net around her.

Juripop is committed to adopting an approach that is sensitive to the needs of the victim.

6. COMPLAINT MECHANISM

a) The person responsible for receiving complaints

The person responsible for handling complaints is Me Justine Fortin, Director of Conjugal, Sexual and Workplace Violence Programs.

In her absence or unavailability, this role is held by Me Sophie Gagnon, Executive Director of Juripop.

b) The procedure for making a complaint

To file a complaint, we invite you to complete the **following form**.

The process can be done completely anonymously, if desired.

c) The right of the victim to be informed of the outcome of his/her/their complaint

In accordance with section 4 of the Act to assist persons who are victims of criminal offences and to facilitate their recovery, a victim has the right to be informed of, among other things, any complaint process and its outcome, if any.

d) The time it takes to process a complaint

A maximum of thirty (30) days may be required to process a complaint.
